Calegories Maximum size in any category may not exceed 30" x 42".

- 2D Must be flat art that is framed and has wire on back for hanging
- **3D** Must be multi-dimensional and can be displayed on a table or the floor

In the event that an insufficient number of entries preclude reasonable competition in any category, the Fine Art Show Committee reserves the right to reduce the number of prizes awarded. Category for each entry will be determined by the Show Chair at the time of registration.

Reasonable care will be taken to safeguard all entries while on exhibit.
